



LEC Panel, Inverter and Controller Limited Warranty

CeeLite® Technologies LLC ("CeeLite®"), 66 Bethlehem Pike Colmar PA 18915 warrants that its LEC Panels, Inverters and Controllers will be free from any defects in material and workmanship for the following time period:

- **1 year from date of purchase by the end user**

Terms and Conditions

This Warranty is not applicable to any LEC Panel, Inverter or Controller which is not installed and operated in accordance with the current edition of The National Electric Code (NEC), the Standards for Safety of Underwriters' Laboratory, Inc. (UL), the Standards of The American National Standards Institute (ANSI), with CeeLite's published Product Handling Guidelines and Operating Instructions. LEC Panels, Inverters or Controllers operated in any system, which has been subjected to abnormal stresses such as, but not limited to, excessive temperatures, excessive humidity or moisture levels, or over or under voltage conditions, are excluded from coverage under this Warranty.

LEC Panels must be operated on the appropriate CeeLite Inverters, and within electrical values noted on the Inverter label.

LEC Panels must be handled in a suitable manner. Delamination, cut, torn or ripped LEC Panels and pigtailed, creasing, or other symptoms indicating **improper** handling voids all Warranty claims.

CeeLite will guarantee the LEC Panel color and brightness as per published specifications. Minor color and brightness variations between LEC Panels are normal. CeeLite specifically excludes from Warranty any color shift of LEC Panels when exposed to high levels of Ultra-violet light.

CeeLite may correct any defects, at CeeLite's option, by repairing any defective part or parts **or** by replacing any defective part or parts **or** by making available new replacement LEC Panels, Inverters or Controllers.

End user will, upon the request of CeeLite, cooperate with CeeLite in any reasonable manner in pursuing LEC Panel, Inverter or Controller Warranty claims. CeeLite reserves the right to examine all failed LEC Panels, Inverters or Controllers, and reserves the right to be the sole judge as to whether any LEC Panels, Inverters or Controllers are defective and covered under this Warranty. The conditions of any test concerning any LEC Panel, Inverter or Controller which is claimed to have not performed to this Warranty shall be mutually agreed upon in writing, and CeeLite shall be notified of, and may be represented at any such tests.

Limitation of Liability

This Warranty, and the replacement of defective CeeLite LEC Panels, Inverters or Controllers, shall be the sole remedy of the end user, and the sole liability of CeeLite to the end user. **NO IMPLIED WARRANTY OR MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS MADE OR IS TO BE IMPLIED.** CeeLite will not under any circumstances, whether as a result of breach of contract, breach of warranty, tort, strict liability or otherwise, be liable for consequential, incidental, special or exemplary damages including but not limited to loss of profits or revenues, loss of use of LEC Panels, Inverters or Controllers or any other goods or associated equipment or damages to any associated equipment, cost of capital, cost of substitute products, facilities or services, down time cost, or claims of claimant's customers.
